**Band Council Resolution** of \_\_\_\_\_

**Whereas** the \_\_\_\_\_ First Nation maintains that, since time immemorial, it has been and is a sovereign nation and affirms its inherent right to self-government by designating the *Chief and Council* to act on its behalf; and

**Whereas** under the terms of the *Framework Agreement* signed by the Province of Saskatchewan and the *FSIN* through the Chiefs in Assembly, each First Nation must pass a *Band Council Resolution* as a jurisdictional and legal requirement to designate a gaming licensing authority if the First Nation is involved in gaming activities within its reserve; and

**Whereas** *Chief and Council* of the \_\_\_\_\_ First Nation has designated *Indigenous Gaming Regulators, Inc. (IGR)* as a lawful and credible licensing authority that has the capacity to license and regulate lottery schemes on-reserve; and

**Whereas** *IGR*, on behalf of the First Nations of Saskatchewan, has entered with the *Saskatchewan Liquor and Gaming Authority (SLGA)* into a *Licensing Agreement* that provides *IGR* with the authority to conduct on-reserve charitable gaming licensing; and

**Whereas** the *Chief and Council* recognize that \_\_\_\_\_ is an *unincorporated non-profit organization* operating within its jurisdiction, and that its current Executive is comprised of individuals with good character.

**Now therefore be it resolved that:**

The *Chief and Council* of the \_\_\_\_\_ First Nation recognize the importance of *licensing* on-reserve charitable gaming activities pursued by a charitable or religious organization for charitable purposes in order to fulfil the federal and provincial requirements; and

Through this *Band Council Resolution* the \_\_\_\_\_ is acknowledged as a charitable organization in the community;

This *Resolution* shall take effect immediately after approval and shall suffice for the purpose of providing acceptable forms of incorporation as specified by *IGR*.

This *Band Council Resolution* may be terminated or revoked if it is evident that the charitable organization has not fulfilled the obligation or intent of the *IGR* issued licence; or if it is evident that the organization has conducted activities that are unacceptable to **Chief and Council**, Elders, and the community.

Upon execution, a copy of this *Band Council Resolution* is provided to *IGR* for its records.

The **Band Council**, who has reviewed the terms of this *Resolution* at a **Band Council** meeting duly convened and with a quorum of the present **Council**, approves its terms and resolves that it shall be executed and issued on those terms.
